Information ex art. 13 Legislative Decree 196/2003

Dear member,

Our Association will process your personal data in compliance with Legislative Decree 196/2003 ("Data Protection Code"), in lawfulness and honesty, assuring data protection and privacy.

Your rights

You can also totally or partially refuse the data processing, even if they are processed in accordance with Association purposes.
